TOURNAMENT CONDITIONS

1. **TOURNAMENT COMMITTEE:** The Tournament Committee shall comprise the Tournament Director and selected members of Sun City Country Club. In the absence of the full committee, such members present at any time may give a decision and any decision given shall be deemed the decision of the full Tournament Committee.
2. The Tournament Committee shall have the sole management and control of the tournament, with full power at any time to alter or vary any of the conditions.
3. **RULES:** The rules of golf as adopted by the Royal and Ancient Golf Club of St Andrews and such local rules as are in force on the course over which the tournament is being played will apply (see Local Rules sheet on the day). If a dispute arises on any point, it shall be decided by the Tournament Committee whose decision shall be final.
4. **PROTESTS:** The Tournament Committee's decision on matters affecting the Tournament shall be final. Protests must be made in writing and submitted to the Tournament Committee within 10 minutes of the conclusion of the days play.
5. **TEE-OFF TIMES:** A copy of the draw will be made available prior to the Tournament. The first groups will tee off at 11:00am. All players are expected to arrive at least 30 mins prior their tee time to register and sufficiently warm up prior to play. The draw will be seeded where possible,
6. **ENTRIES:** Entries close on Tuesday 19th August 2014. The Tournament Committee reserves the right, in special circumstances, to accept late entries after Tuesday 19th August 2014. Fees must be paid at the time of entry. Refunds will only be forwarded provided that notification is given at least 5 days prior to the Tournament. The Tournament Committee has the right to refuse the entry of any person for the event, without being required to give a reason for doing so.
7. **REGISTRATION:** All players whose entries have been accepted must register at least 30 minutes prior to their tee time.
8. **AGE DIVISIONS:** The Tournament Committee reserves the right to alter age divisions depending on the number of entrants in any particular division.
9. **TIES:** In the event of a tie for the winner of the open division, a play-off will occur as decided by the Tournament Committee, until a winner is determined. Play off will be played on the 9th Hole until a winner is decided by sudden death play-off.
10. **HANDICAP LIMITS:** The Junior Open Division handicap limit is 36 for boys and 45 for girls. The Amateur Open handicap limit is 15 for Males. Entrants who possess a club handicap in excess of these limits MAY be accepted AND must play within these handicap limits.
11. Scorecards signed by the marker and counter-signed by the player must be returned to the Tournament Office immediately on completion of a player's round. Breach of this condition may mean disqualification.
12. **DRESS REGULATIONS:** At all times, particularly in the golf clubhouse, it is expected that all players will observe dress regulations which are standard at most clubs: neat attire, including street shoes to be worn in the Clubhouse at all times. No joggers or golf shoes are to be worn in the Clubhouse.
