



CONDITIONS FOR AFFILIATION AND MEMBERSHIP

- Any club may apply for affiliation with Golf WA **providing the club has a constitution or set of rules which is accepted by Golf WA.**
- Golf WA reserves the right to accept or reject any application for membership / affiliation without providing any reason whatsoever for its decision.
- The club is required to submit a club affiliation form and individual member declaration on an annual basis. The club shall pay an annual affiliation fee based on the number of playing members within the club.

Note: The affiliation fees are due and payable by January 1 in each year and no later than March 1 in each year.

- Members of all clubs are required to observe the rules and regulations of any club or course at which they may visit.
- It is the prerogative of any golf club which conducts open golf competitions to determine the eligibility conditions of entry into such competitions. Golf WA cannot guarantee that entry into these competitions will automatically apply.
- The club agrees to –
 - a) Abide by any further regulations and conditions as laid down by Golf WA.
 - b) Accept in their entirety and abide by the Rules of Golf and the Rules of Amateur Status as laid down from time to time by the Royal and Ancient Golf Club of St Andrews.
