### OPEN CATEGORY

Due to the lack of the clubs nominating teams for the Open Category this category will not be conducted this year and these teams have been moved into the handicap pools.

### HANDICAP CATEGORY

- Comprises 17 teams split into four Pools (Three with four teams and one with five teams). As per previous years and information provided the split has been based on the below in order:
  1. Preferred day for play
  2. Handicap range as per nomination forms.
  3. Proximity of home club to other teams.
- Teams with a Saturday preference have been split into three "pools" (2 of 4 teams and 1 of 5 teams) and will compete in a random home and away draw.
- For **Pool A1, A3 and Pool B teams** will play home and away and note that numbers or letters have no relevance to handicap range they are simply separate pools.

Finalists in this Pool will comprise of the top two teams at the completion of qualifying matches competing in the final on Sunday 25 July at a venue TBC.

- For **Pool A2 teams** the format of the finals will the team that finishes on top of the ladder after week 5 will proceed directly to the finals (Week 7). The teams finishing in the 2<sup>nd</sup> and 3<sup>rd</sup> position will compete in Week 6 for the right to play in the final (note the team finishing second will have the home course advantage and will therefore be responsible for booking the game).

Teams finishing 4<sup>th</sup> and 5<sup>th</sup> are encouraged to play in Week 6 with the 4<sup>th</sup> placed team having the home course advantage.
