Introduction and Purpose

GolfWA is a non-profit State Sporting Association appointed as the governing body and promoter of golf in Western Australia. The objects of the Association are to grow the game of golf through equitable and inclusive practices that provide opportunities for participation at all levels in golf. An important way to achieve these objects is to communicate with our stakeholders in a way that engages them in everything we do.

GolfWA defines a stakeholder as a person, group, or organisation that has a direct or indirect stake in GolfWA where they may affect, or be affected by GolfWA's actions, objectives, and policies.

GolfWA has a direct need to communicate with all of its stakeholders, this document aims to provide a view of what GolfWA does to engage its stakeholder community.

Key Stakeholders

GolfWA's key stakeholders include affiliated clubs and their members, district associations, customers, directors, employees, government (and its agencies), suppliers, and the community from which GolfWA draws its resources.

All stakeholders are not equal and different stakeholders are entitled to different considerations.

At present GolfWA's key stakeholders (in no particular order) include:
